RSS and regional LHN Diabetes Educator Workshop 2024



The regional LHN Diabetes Educator's Workshop was held on the 20th and 21st June 2024 at the Education Development Centre, Hindmarsh. This face to face event was well attended by 34 rural and remote Credentialled Diabetes Educators (CDE) and Diabetes Educators (DE).

The program offered various speakers and presentations on pathology on diagnosis and on clinical review, diabetes and disability, health care worker training, type 2 diabetes glycaemic management algorithm, weight management options, diabetes distress - assessment and management, correctional services and diabetes management, insulin titration and the national diabetes nursing education framework.

The regional LHN CDEs and DEs (pictured left) also utilised the opportunity to present a case study or project report. Initial evaluation has identified that the program was well received, highly relevant to clinical practice and that a number of aspects of practice will be actioned as a result of attendance.

Latest News

Australian Government ban on compounded replica type 2 diabetes and weight-loss drugs

The Australian Government is acting to protect Australians from the risks posed by injecting potentially unsafe and dangerous compounded replicas of weight loss products. Compounded glucagon-like peptide-1 receptor agonists (GLP-1RA) products are not identical to the Therapeutic Goods Administration (TGA) approved products Ozempic® (semaglutide) or Mounjaro® (tirazapetide). Unlike TGA approved products, pharmacy-compounded products are not clinically evaluated by the independent regulator for safety, quality or efficacy. At least 20,000 Australians are injecting these compounded replica weight loss products. The majority do not have diabetes and are using these medications for weight loss management.

This change will take effect from 1st October 2024, to allow people time to consult with their doctor and prepare alternative management plans appropriately, including, where necessary, sourcing a safer, regulated alternative. Medicine Shortages

The TGA identifies the following medication shortages:

- > Humulin 30/70 biosynthetic human 30% neutral 70% isophane insulin 100IU/mL injection 10mL vial
- > Humulin R insulin 100IU/mL injection vial
- > Fiasp insulin aspart (rys) 100 units/mL solution for injection 10 mL vial.
- > Ryzodeg 70/30 Flextouch 70% insulin degludec (rys) / 30% insulin aspart (rys) 100 U/mL solution for injection cartridge
- > Diaformin XR metformin hydrochloride 500mg extended release tablet blister pack
- > Glicalzide MR 30mg tablets blister pack.

These products have limited availability due to manufacturing and/or transport, logistic issues and storage capacity issues. More information about medicine shortages and how to access alternative medicines is available at the TGA website.

Screening for type 1 diabetes

The risk of type 1 diabetes in someone with a first-degree relative with type 1 diabetes (e.g. biological parent, sibling or child) is around fifteen times higher than for the general population. The only way to detect type 1 diabetes early is through population-wide screening. International guidelines support screening in both family members and the general population for improved health outcomes, and while it is still largely offered through research trials, it is expected to become the standard of care.

The <u>Type 1 Diabetes National Screening Pilot</u> funded by the Juvenile Diabetes Research Foundation, aims to find the best way to offer screening for type 1 diabetes to children in Australia. The final results of the pilot study are expected at the end of 2024.

The <u>Type 1 Screen</u> offers free screening for family members aged 2 years and older and consenting participants will be asked to arrange the blood test, either through a local pathology collection centre or by ordering a finger prick test kit sent to their home to do themselves. Participants are informed of their results within two months of the sample being received. If diabetes antibodies are identified, a second (venous) blood sample will be used to confirm the finding and the participate will be linked to the closest participating diabetes centre to learn about symptoms of diabetes and will be offered opportunities to participate in studies that aim to prevent or delay the onset of diabetes.

SA Health High Risk Medicines Management Policy

The SA Health <u>High Risk Medicines Management Policy</u> was approved in May 2024 and provides the mandatory requirements for the management of high-risk medicines across SA Health services to ensure compliance with the Australian Commission on Safety and Quality in Health Care (ACSQHC) National Safety and Quality Health Service Standards.

Australian Type 2 Diabetes Glycaemic Management Algorithm

The Australian Type 2 Diabetes Glycaemic Management Algorithm was reviewed in June 2024 and outlines the risks, benefits and costs of available therapies and provides an approach for how to incorporate older and newer agents.

Control of blood glucose levels in people with type 2 diabetes has clear benefits for preventing microvascular complications and potential benefits for reducing macrovascular complications and death.



ADS Managing Type 2 Diabetes with Therapeutic Carbohydrate Reduction Statement



Therapeutic carbohydrate reduction (TCR) is one of a number of options for the management and potential remission of type 2 diabetes. Improvement in glycaemic control, weight loss and the reduction in the need for glucose lowering medications and in blood pressure can be achieved by treating type 2 diabetes with TCR.

The Australian Diabetes Society (ADS) Clinical Advisory Committee Statement is designed to aid medical management of individuals who have decided to undertake TCR and offers information on goals of TCR, clinical considerations, absolute contraindications, antihypertensive medication and lipid management.

JDRF Straight to the Point

Straight to the Point is a helpful guide to living with type 1 diabetes as an adult. The 2024 edition has been updated with new information including: tech & devices, travelling, work, financial assistance, mental health, body image and social life & relationships.

National Disability Insurance Scheme diabetes management supports

All NDIS funded supports must meet the NDIS Funding Criteria. If a person with diabetes and a disability cannot their diabetes because of their disability, NDIS may fund:



- > a nurse to create a disability-related diabetes management plan
- > training for support workers in the person's diabetes management needs
- > a support worker or nurse to monitor glucose levels and administer diabetes medication
- > <u>assistive technology</u> (e.g. continuous glucose monitoring system, continuous subcutaneous insulin infusion).

Health care professionals (HCP) are often the first people a person with diabetes and a disability turns to for support with connecting to disability supports. A HCP can support a person and/or their carer to complete an access request form, providing the supporting evidence and encouraging them to contact their local NDIS office on 1800 800 110.

The State of the Nation 2024

Recently released, the Diabetes Australia The State of a Nation Report 2024 lays bare a sobering reality: Australia is in the grips of a diabetes epidemic. At the heart of this epidemic are 2 million Australians living with diagnosed and undiagnosed diabetes, and many more at high risk.

The Report presents comprehensive information about which Australians are most at risk, the severity of diabetes complications for individuals as well as the health system and economy. 25 Key Recommendations call for urgent action on a national level pertaining to prevention and screening, care and treatment, vulnerable communities and research.
